When users visit our Website (<https://neurolytics.ai/>), we may use cookies and other technologies (such as trackers and pixels) to enhance your experience on our Website by providing the users a better, faster and safer experience.

This may involve a recognition of your browser or device, the user's preferences, the pages the user visit, how the user interacts with our Website and to offer the user further services. Please visit our [Privacy Policy](#) for more information on our data protection practices. This information may not usually identify the user as a person directly, but may be able to provide a more personalized experience while using our Website and services.

The user consents to necessary cookies by using our Website and to other cookies by clicking "Allow all" or "Allow selection". A user can click on "Show Details" on the cookie banner to find more details about the cookies we use on the Website. 2. What are cookies?

A cookie is a text file sent to a user's web-browser and stored in the user's browser or device, containing information about the user and used to subsequently identify the user that enables features and functionality. Such cookies are unique to your browser.

We use session-based, persistent-cookies, first party cookies, third-party cookies, necessary cookies, preference or functional cookies, analytics or statistical cookies, marketing cookies:

- a. **Session-based cookies**, are cookies which are sent to your browser and exists only for the duration the browser is open and are automatically deleted when a user terminates the use of the web-browser.
- b. **Persistent cookies**, are cookies which are stored by your browser until you or the browser deletes these cookies or the cookies may expire.
- c. **First-party cookies**, are cookies which are sent from the neurolytics.ai domain.
- d. **Third-party cookies**, are cookies which are managed by certain other approved third parties. These cookies are used to measure the effectiveness of our Website and Services. The personal data collected and processed by these third parties, is subject to their respective privacy policies. The list of third parties can be found [here](#).
- e. **Necessary cookies**, are cookies which enable us to provide a user a safe, secure and stable use of the basic functions of the Website.
- f. **Preference or functional cookies**, are cookies which allow us to remember the personalized settings of the user provided on the website.
- g. **Analytics or statistical cookies**, are cookies which allow us to analyse the behaviour of a user on the Website to measure and improve the experience of the user on the Website.
- h. **Marketing cookies**, are cookies which are used to provided bespoke or tailored advertising to a user based on the interests within the Website and outside the Website.

3. Why we use cookies?

We use cookies to give users the best possible personalized experience on our Website by letting users navigate between sub-pages of the Website efficiently, verify the user, carry out other essential security checks, remember your preferences for a session or for between visits to the website, continuously improve the Website and Services.

4. How can you manage cookies?

When a user first lands on the Website, the user will be asked to choose the cookie setting and by accepting the cookie settings, you provide consent to set the cookies in accordance with this Cookie Policy. A user can always opt out of the cookies by changing the cookie settings at the bottom of the Cookie Policy page.

Please note that if you disable some and/or all cookies in your browser settings, neither we nor third parties would be able to place cookies in your browser. This may fundamentally affect the proper functionality of our Website. You may also have to manually adjust your settings every time you visit. This may impact your experience of the Website and Services which we offer.

5. How to stay up-to-date about the Cookies?

In view of possible future changes to our Website or changes in legal requirements pertaining to the use of cookies, we may change this cookie policy from time to time without notice. You can read the most current version of this cookie policy, by clicking on the "Cookie Policy" at the bottom of the page. 6. Will a user who rejects a cookie still be able to use our Website?

We use cookies for a variety of reasons, such as to determine preferences, let users navigate between pages efficiently, verify the user and carry out other essential security checks, and enable the user participate in our online video assessment. Therefore, the user will be able to use the Website and our Services by consenting to the necessary cookies.

7. Do cookies mean I could get cold calls or junk mail?

We never use the data gathered through cookies to contact a user via post, email or telephone. We may use cookies to show a user subtly tailored content on our Website or other websites of things we think a user maybe interested in, but only in relation to Neurolytics products and services, only if you consent to the marketing cookies.

8. Do cookies compromise my security when I am logged on to this website?

The cookies we use are subject to legal compliance by us and by third parties as required. Many of the cookies are used for providing important security features such as protecting your accounts, ensuring security and safety of the Website.

9. What about cookies on third party websites we provide redirecting links to?

When we include links to other websites, please bear in mind they will have their own privacy and cookie policies that will govern the use of any information a user submits to them.
